# Pay for Quality Provider Incentive Plan

Through our Pay for Quality (P4Q) program, we reward you for helping us meet HEDIS® quality measure standards. The goal of our program is to target Healthy Blue members who need one or more HEDIS-measured procedures or visits completed during the 2023 calendar year. Program objectives are to improve targeted clinical quality results, promote safe and effective patient care, and increase preventive care services for our members.

The HEDIS measures along with your potential 2023 incentives are as follows:

APP First-Line Psychosocial Care (12-17 years)	Percentage of adolescents ages 12 to 17 who had a new prescription for an antipsychotic medication and had documentation of psychosocial care as first-line treatment	\$20
IMA Immunizations for Adolescents — Combo 2	The percentage of adolescents ages 13 years of age who had one dose of meningococcal vaccine, one tetanus, diphtheria toxoids and acellular pertussis (Tdap) vaccine, and have completed the human papillomavirus (HPV) vaccine series by their 13th birthday	\$40
CIS Childhood Immunization Status — Combo 10	The percentage of children 2 years of age who had four diphtheria, tetanus and acellular pertussis (DTaP); three polio (IPV); one measles, mumps and rubella (MMR); three haemophilus influenza type B (HiB); three hepatitis B (HepB), one chicken pox (VZV); four pneumococcal conjugate (PCV); one hepatitis A (HepA); two or three rotavirus (RV); and two influenza (flu) vaccines by their 2nd birthday. Note: LAIV (influenza) vaccination must occur on the child's 2nd birthday	\$40

#### Frequently asked questions

### When can I expect to receive my incentive payments?

There will be one incentive payment for 2023. The payment is scheduled to be made in July 2024.

### How can I expect to receive my incentive payment?

If you are currently enrolled in electronic funds transfer (EFT), you will receive your payment via EFT. If you are not currently enrolled in EFT and receive mailed checks, you will receive this payment via the U.S. Postal Service.

#### Who is eligible to participate in this program?

Only those PCPs not participating in another provider incentive agreement are eligible to participate in this program.

#### If I am not the member's PCP, can I still receive the incentive?

No, only the member's assigned PCP is eligible to earn the incentive.

#### How will Healthy Blue know if I provided one of the services above?

Incentives will be determined based on claims data received. It is imperative that you bill using the appropriate CPT®/HEDIS-compliant code in order to ensure an incentive payment.

## How does this information feed into the *Opportunity Report* I am receiving?

Our incentive plan and *Opportunity Reports* are directly related. The incentive is only payable for those members who appear on the report and receive the specific services identified in the report.
